Intensive CFE Exam Review Course

The CFE Exam Review Course is available in Mexico.

The course is taught by qualified trainers from the Association of Certified Fraud Examiners in Austin, Texas.

What are Certified Fraud Examiners?

CFEs are anti-fraud experts that have accredited their knowledge through experience and by passing the CFE Exam. The CFE Exam tests knowledge in: financial transactions and fraud schemes, fraud investigation techniques, legal elements of fraud, and fraud prevention & deterrence.

The CFE credential is recognized by private institutions and government entities worldwide. It accredits that the professional who obtains it has specialized knowledge in the field of fraud prevention, detection and investigation. The international certification as a CFE is the worldwide distinction that an antifraud professional acquires as a specialist in the field of fraud deterrence, detection and investigation. It is granted by ACFE after the fulfillment of requisites and the passing of the corresponding exam.

This course will be given in English. It will provide the necessary knowledge to pass the International version of the CFE exam through 8-hour daily interactive practice sessions. This will ensure effective learning to acquire the necessary knowledge to pass the exam.

After each daily session, the participant will take the section of the exam that corresponds to the section studied on that particular day. On Friday 28, the last scheduled class; students will take the last section of the exam from 4:30-6:30 pm, including and make-up exams for sections that they failed in previous days.

All CFE candidates are required to pass a 500 question exam covering the four main areas of fraud examination. If you create a weekly study plan, you can be certified simply studying on your lunch hour. Begin by choosing a study schedule you can fit into to your current schedule. Based on the suggested study times listed below, set a manageable goal for completing the CFE Exam Prep Course and CFE Exam. Study for about 1 ½ - 2 hours each study day. Select the timetable to help determine which formula best suits your needs.

Target Days to Completion	Study Time Required Per Week
30 days	Ten hours
60 days	Five hours
90 days	Three hours

Requirements: Must be an ACFE member, fulfill prerequisites and submit the CFE Exam application prior to the course. For this reason, it is very important to register ASAP. Our Certification team will make sure that all of the attendees send in all the necessary documentation. We kindly ask you to review all the information and requirements shown in www.acfe-mexico.com.mx. Please fill out application for the submission of the CFE exam that is located in www.acfe.com and send it together with your academic and professional profile. Three recommendation letters in English given by professional references are required. They must endorse the candidacy of the participant to submit the CFE exam.
